# Poor Service Delivery: Bogoro Cautions TETFund Beneficiary Institutions

he Tertiary Education Trust Fund, (TETFund) has charged the 226 public tertiary institutions statutorily benefiting from its interventions to inculcate efficient service delivery that would ensure that Nigerian higher institutions compete favourably with the best in the world.

The fund warned that its desire to achieve results in line with its mandate could be jeopardised if tertiary institutions would render dysfunctional services.

The Executive Secretary of TETFund, Professor Suleiman Bogoro, who stated this recently in Abuja at a workshop organised by the fund for nodal officers and directors of quality assurance of the 226 beneficiary institutions with the theme: "Building Skills for Effective Service Delivery," noted that the workshop was organised by the fund to engender synergy between the agency and its beneficiaries.

Bogoro said: "We want to achieve result as TETFund in line with our mandate. However, this could be jeopardised if there are dysfunctional in our beneficiary institutions.

# NUC Issues Provisional Licenses To 20 More Private Varsities The remaining are (11) Ahman Pategi University, Patigi, Kwara State, (12)

he National Universities Commission (NUC) will issue Provisional lecenses to 20 new Private Universities tomorrow. This will bring to 99, total number of Private Universities in Nigeria.

The licenses which will be issued by the Minister of Education, Malam Adamu Adamu will be reviewed after three years prior to issuance of full licences.

List of the newly approved Universities and their locations include - (1) Mudiame

University, Irrua, Edo State, (2) Claretian University, Nekede, Imo State, (3) Ave-Maria University, Piyanko, Nasarawa State, (4) Topfaith University, Mkpatak, Akwai Ibom State.

The remaining are - (11) Ahman Pategi University, Patigi, Kwara State, (12) ANAN University, Kwall, Plateau State, (13) Capital City University, Kano, Kano State, (14) Edusoko University, Bida, Niger State, (15) James Hope University, Agbor, Delta State.

To be sure all processes are completed before the commencement, the Board didn't place its advertorial as it was yet to complete the process of a smooth pin vending and candidate access to the registration app for

the 2021 UTME/DE," it explained in the statement.

The statement further explained that:"

The advertisement is the surest indication of the beginning of the exercise as it has all the step by step process that candidates are required to follow."

He participated during clashes on the ship including the attacking of two Israeli commandos.



**Prof. Webster Griffin Tarpley,** is an American author, historian, journalist, lecturer and critic of U.S. foreign and domestic policy. Some of his publications revolve around conspiracy theories. He founded the Tax Wall Street Party. Tarpley is a member of the "world anti-imperialist conference" Axis for Peace of Scholars for 9/11 Truth and of a research Netzwerk of German 9/11 authors founded in September 2006. Tarpley has also expounded the "Versailles Thesis" laying the blame for the great wars of the 20th century on intrigues by Britain to retain her dominance.



"The hallmark of the fund is built on the bedrock of effectiveness and efficiency. This is because of the anticipated impact we seek to achieve in all our beneficiary institutions."

Bogoro, who was represented by the Director of the Office of the Executive Secretary, Mr. Uchendu Wogu, said the theme of the workshop was crafted on the premise of building skills in the benefiting institutions.

The TETFund boss said the training would equip participants with skill-oriented ideas in the face of global competitiveness, adding that key objectives of building skills for effective service delivery would be extensively delivered by experienced resource persons.

He said that the areas of interest in the training would include "quality assurance methods and enforcement in infrastructure and content abased interventions in the beneficiary institutions," as well as "strategic planning, corporate objectives and call analysis; effective communication and efficient service delivery in the era of ICT," among others.

Speaking on the expected outcome of the workshop, the National Coordinator of SERVICOM, Ms. Nnena Akajemeli, expressed confidence that the training would enhance better management of processes and systems, and would be monitored to measure compliance. Akajemeli said that satisfaction and quality to measure compliance.

She further stated that quality and honest feedbacks are expected from the beneficiary institutions at the end of the training; as well as better engagement between the institutions and the service providers in TETFund.

"We expect effective partnership thereafter; and the new intervention guidelines are also here and so they are going to take them through the processes of these guidelines and what it entails.

"It is preparing them to come forward with their expected obligations; so at the end we expect enhanced engagement between the beneficiary institutions and their service provider, TETFund," she said.



## Report on the NIALS Virtual Roundtable on Nigeria's Single Digital Identity Roadmap: Issues, Challenges and Prospects (II)

from last edition

ince registration the commenced in 2012, the Commission has been able to register 40.8 Million Nigerians. The NIMC Act 2007 establishes that the Commission shall create, manage, maintain and operate the National Identity Database (NID) including the harmonisation and integration of existing identification databases in government agencies and integrating them into the NID. The Commission is well placed to facilitate integration and unified identity framework.

## Digital Identity as a key element of a digital economic framework.

While noting that Nigeria is at intermediate level of development with a fragmented identity landscape, the next speaker, Mr Oluwafemi Osho posited that digital identity aids the strengthening of public confidence in the use of digital technologies and participation in the digital economy. He noted that through the fragmented data gathering practice by several organisations and the data with NIMC, only 28percent of the hundred million six hundred thousand (106 million) estimated population of Nigerians has been captured. The presenter explored how an identity program can enable digital economy

#### Role of Public Private Partnership in Nigeria's National Identity Management Strategy.

Mr Segun Odegbami in discussing Role of Public Private Partnership in Nigeria's National Identity Management Strategy, made a strong case for the infrastructural strategic steps taken by the NIMC since inception towards achieving its mandate as provided under the NIMC Act 2017. The NIMC is partnering with the private sector by requiring agencies to demand NIN at the of point accessing services thereby making NIN a means of ID in the country. According to him, building a digital identity ecosystem is very capital intensive especially for an organisation like NIMC without the funding it needs to build and sustain the ecosystem. PPP becomes an important means of reducing the cost of ecosystem generation and also generate funds while doing same by bringing investors that can help to build, justified by a revenue ecosystem, which is part of PPP value chain.

#### ICT and the single Identity Roadmap: The prospects of enforcing a Harmonisation Narrative.

Regarding harmonisation, Mr Edet the Head of Legal and Board



DG NIALS, Prof. M T Ladan received the DG National Institute for Legislative & Democratic studies,NASS ABUJA, on Tuesday 30th March 2021 on a courtesy visit to cement their Partnership on capacity building in Legislative Drafting matters, Law review and Advanced Policy Research in Legislative and Policy Matters for National development

Matters unit stressed the importance of the digital identity management and Information Communication Technology (ICT) nexus. He went on to highlight the distinction in the form of data-fundamental, functional and transactional data- collected in various identity management systems. The distinction in the categories of data makes it imperative in his view, for all agencies to continue to gather identity data while its managed by NIMC.

Mr Edet further identified the existence of challenges to data harmanisation due to the restricted mandate of the respective agencies in their enabling laws. In addition, the presenter identified that the need exists for a law to deal with data gathering and not just data security,

#### **Question and Answer Sessions**

Participants made several comments as well as posed a few questions to the speakers and discussants

In replying to the question as to why Nigeria continued with outsourcing digital card management to foreign companies thereby exposing data to compromise, Hadiza Dagabana explained that companies like Verve, Visa and Mastercard all serve as payment partners and do not retain customer data in completing transactions pushed through their systems or platforms.

Mrs Hadiza Dagabana, in response to the question why NIMC charges for card renewal and why the issued cards have expiry dates, explained that the cards by their nature must have expiry dates because of security features and need to catchup with innovations especially on data protection. On charging for renewals, she stated that the federal government planned to pay for initial fifty (50) million cards but however was only able to pay for about two million five hundred thousand cards. The issues of renewals must be borne by individuals seeking renewals and more importantly renewals are not necessary as NIN is permanent for the life cycle of any individual and as such the plastic card is not a requirement for proof of identity.

On a general response note Mrs Dagabana said that NIMC issues regulations and standards on data capture and connectivity of data capturing equipment to send captured data to NIMC. However, agencies must also collect functional data for their specific purposes. She further stated the process of data capturing especially for the seemingly excluded such as IDPs, the federal government has released funds for NIMC to further collaborate with vendors in capturing data of individuals in IDP camps. Currently NIMC has captured only 20percnt of the Nigerian population which is about forty million (40,000 000) individuals.

#### **Closing formalities**

The Director General requested for general remarks from participants especially the council members and professors physically present. Thereafter, the DG thanked the lead speakers, discussants, Council

members present and the general participants for actively engaging with the topic.

The roundtable successfully came to a close at about 2pm.

#### Recommendations and Next Steps Flowing from the deliberations at the

Flowing from the deliberations at the Roundtable;

i. for members of the general public: a. there remains a need to continually interrogate issues relating to data privacy and data security especially as the process of harmonisation of the identity management ecosystem is still on-going;

b. there is need to advocate for the passage into law, the Data Protection Bill as current policies on the protection of personal information do not have the necessary force of law;

c. citizens need to be sensitised as to the expected outcome of the implementation of the current identity management road map;

ii. for NIALS

a. the Institute can leverage on the gaps existing in the understanding of the nexus between digital identity management and digital economy, data privacy and data security, to launch a book project that addresses these issues;

b. engage in collaboration with NIMC and NITDA under the Ministry of Communication and Digital Economy to conduct funded research on data privacy breach mitigation strategies in the identity management ecosystem.

5-year-old CHRISTINE KABAZIRA is one of the two students who attained a First Class Degree in Journalism and Communication. She scored a CGPA of 4.40 emerging second best in her class. Ms. Kabazira is one of the students who will be awarded degrees and diplomas of Makerere University at the 71st graduation ceremony scheduled to take place from 17th-21st May 2021. She appreciates the contribution of her lecturers but mainly attributes her success to her parents, who she says did not study to the highest levels of education, but valued education and sacrificed so much to see her and her siblings go through school. Ms. Kabazira looks up to Prof. Linda Goretti Nassanga and Prof. Monica Chibita, the only two female journalism and communication professors in the country, and hopes to do whatever it takes to become a professor in the same field. The CHUSS Communication Office had a chat with Ms Kabazira. Below are excerpts from the interview.

Education background

Ms. Kabazira joined Makerere University in 2016, from Kyebambe Girls' School in Fort Portal. At A' Level, she studied History, Economics, Literature- HEL/Submaths. Her best subject was Literature though she also loved Economics. From her childhood days, Ms. Kabazira admired the journalism profession. This inspired her to study hard and pursue the journalism and communication programme at University.

Question & Answer

#### How do you feel about the milestone - First Class degree?

I am excited, I feel proud of myself. I believe I am strong because it takes strength to have sleepless nights reading and researching. It takes strength to achieve goals and objectives and for that, I feel strong. I feel that my efforts have paid off because I worked for it



and I prayed for it.

#### What inspired you to pursue this particular programme - Journalism and Communication?

I had always loved to do journalism ever since I was a child. I enjoyed watching Jackie Lumbasi (former news anchor at WBS) as she read news back then and I wanted to be like her. That was when I was a child. But along the way, my reasons for wanting to do journalism kept changing. I wanted to do more than read news on TV. I wanted to be an investigative journalist; uncover the wrongs in society for the good of the people.

Did you have any other programme in

mind before joining Journalism and Communication?

I wanted to do Law but I knew it would not be possible for me to do it on private scholarship because I thought it would be too expensive for my parents to manage.

"Children with severe acute malnutrition are at a significantly higher risk of death as compared to well-nourished children.

"A recent survey found that malnutrition rates in children between six months and

59 months are as high as 10 per cent in Borno and up to 12.3 per cent in Yobe.

"This is well above the 5 per cent threshold globally recognised to be of public health significance.

"With COVID-19 pandemic and the attendant loss of livelihoods and food insecurity, thousands of more children could be at risk of malnutrition-related deaths or stunting in the region this year," she stated.

"The new grant will aid in the early detection and prompt treatment of children suffering from acute malnutrition.

"It will build a strong network of community nutrition responders who can ensure quick referrals of malnourished children to health facilities where trained health workers will be able to help them,"

Adebayo also stated that about 50,000 pregnant and lactating women and other caregivers would be trained to store and cook affordable food for themselves and for their children.

They would also be trained on how to monitor their children's nutritional status at home, she added.

She quoted the Charge d' Affaires of the Japanese embassy in Nigeria, Mr Shinozawa Takayuki, as expressing the hope that the funding would ensure lifesaving nutrition for children's survival in the frontline states.

# 120,000-Year-Old Cattle Bone Carvings May Be World's Oldest Surviving Symbols



he bone in question probably came from an auroch, a large ancestor of cows and oxen that went extinct about 500 years ago. Hunters may have used flint tools—some of which were found alongside the fragment—to fashion the engravings, according to the Jerusalem Post.

Researchers used three-dimensional imaging and microscopic analysis to examine the bone and verify that its curved engravings were man-made, reports the

Times of Israel. The analysis suggested that a right-handed artisan created the marks in a single session.

"Based on our laboratory analysis and discovery of microscopic elements, we were able to surmise that people in prehistoric times used a sharp tool fashioned from flint rock to make the engravings," says study co-author Iris Groman-Yaroslavski in the statement.

Scholars are unsure of the carvings' meaning. Though it's possible that

prehistoric hunters inadvertently made them while butchering an auroch, this explanation is unlikely, as the markings on the bone are roughly parallel—a methodical feature not often observed in butchery marks, per Haaretz's Ruth Schuster. The lines range in length from 1.5 to 1.7 inches long.

"Making it took a lot of investment," Zaidner tells Haaretz. "Etching [a bone] is a lot of work."

Archaeologists found the bone facing

upward, which could also imply that it held some special significance. Since the carver made the lines at the same time with the same tool, they probably didn't use the bone to count events or mark the passage of time. Instead, Zaidner says, the markings are probably a form of art or symbolism.

"This engraving is very likely an example of symbolic activity and is the oldest known example of this form of messaging that was used in the Levant," write the authors in the study. "We hypothesize that the choice of this particular bone was related to the status of that animal in that hunting community and is indicative of the spiritual connection that the hunters had with the animals they killed."

Scholars generally posit that stone or bone etchings have served as a form of symbolism since the Middle Paleolithic period (250,000–45,000 B.C.). But as the Times of Israel notes, physical evidence supporting this theory is rare.

Still, the newly discovered lines aren't the only contenders for the world's earliest recorded symbols. In the 1890s, for instance Dutch scholar Eugene Dubois found a human-etched Indonesian clam shell buried between 430,000 and 540,000 years ago.

Regardless of whether the carvings are the first of their kind, the study's authors argue that the fragment has "major implications for our knowledge concerning the emergence and early stages of the development of hominin symbolic behavior."

## NUC: Assessing the Assessors

he National Universities Commission is a body first set up in 1962 inside the Cabinet Office as an advisory agency which, over the years, metamorphosed into a corporate body enacted by statute in 1974, under its first Executive Secretary, Professor Jibril Aminu. It is now one of the most active and commonly recognised regulatory agencies firmly embedded in the Federal Ministry of Education. Its mission statement states: "To be a dynamic regulatory agency acting as a catalyst for positive change and innovation for the delivery of quality university education in Nigeria". On any rational examination of the agency, it is anything but "dynamic". On the contrary, it has remained static and highly bureaucratic, with a jaundiced view of higher education incompatible with the needs of today's diversified and fast-moving knowledge acquisition from multiple sources. Its remit and raison d'être have not been reviewed for 60 years. Its service delivery has remained in-ward looking, dreary and notoriously predictable. A centralised education system is the anti-thesis of "dynamism", "positive change", and "innovation". Its rigid hold on the education system in a multi-ethnic, multi-nation, federal state is backwardlooking, especially when there is pressure on countries to "roll back" the frontiers of the state in all other aspects of public life. Let us dig deeper.

Part of the mandates of the NUC is to: grant approval for all academic programmes run in Nigerian universities; establish all higher educational institutions; maintain quality assurance of all academic programmes; channel external support to Nigerian universities, among others. To achieve this, its administrative structure consists of a Governing Council, and

a Secretariat with 12 Directorates: Academic planning, inspection and monitoring, management and support, students' support, establishment of private universities, research, innovations and information technology, etc. It is clear the NUC is a behemoth, breathing down the necks of every university in Nigeria. This cannot possibly be right. That no audible objection is being raised about this all too pervasive and intrusive body by people at the receiving end of its sharp edge is puzzling, to say the list. My best guess is that this is a result of a cosy entente cordiale that exists between senior academics in the universities and the management of the NUC. All the more reason for the public concern reflected in this piece.

To be fair to the agency, originally, there was a perceived need to have a single authority to coordinate the academic programmes of existing and new institutions to ensure and uphold uniform standards. This is especially so in view of the fact that the universities were, almost invariably, taxpayer-funded. However, in 2021, delivery of university education is no longer the preserve of government alone. Churches, consortiums, voluntary organisations and individuals also provide university education for the public. Moreover, the ultimate arbiter of quality education in today's world can no longer be government bureaucrats, it has to be the beneficiaries of qualified graduates from the universities; the employers of labour.

With their clipboard and Bic biro to hand, the NUC regularly turns up at the door of universities to carry out periodic, in some cases, sporadic inspection of their curricula, checking for conformity to laid-down rules. This has become a huge ceremony, and fanfare, overlaid by

enthusiasm and apprehension in varying circumstances. The very fact of a visit by a NUC accreditation team now represents a theatre in which everyone dances to a wellrehearsed tune. They come wielding the big stick of "accrediting" or "de-accrediting" a particular programme, department, faculty, or even an entire institution. They go round, bleary-eyed, ticking boxes like you see election observers do, except that they carry such awe and such menace on their faces akin to the Gestapos. They delight in probing into every minutiae of a university's programme: how many students have enrolled on a particular course, and a particular unit; over what period of time; the topics being covered in a chronological order; how many textbooks in the tutor's office; how many contact hours with students; classroom space; how much time is taken for tea-break, etc. Pretty mundane and inane. Let us face it, and as menacing as they make themselves look at times, there is practically nothing the NUC demands of a resourceful institution that would not miraculously appear in time for an accreditation, even a fresh human skull. Everyone plays to the gallery, of course. The NUC officials are good at many things; thinking outside the box is not one of them.

Accreditation (the crown jewel in their armoury), has degenerated into an expensive charade in its manifestation. But, never mind, everyone revels in the ritual anyhow. Nigerians can be so compliant, and are generally too happy to give robotic answers to predictable questions from officialdom. In turn, some Nigerian academics have taken leave of their senses too. Many no longer understand the meaning of "academic freedom" they profess and cherish so much. Globally, academic freedom is at the core of any university's standing. It has been circumscribed in

Nigeria by over-zealot NUC staffers in the name of enforcing uniform standards. Oh, let us not teach this or that, because the NUC team may not approve. Or, this or that course unit has either been ruled out, or not yet sanctioned by the NUC, so, let us not dare expose our students to it, and other similarly mind-numbing banalities. Many have forestalled their own ability for creative thinking and foresight, as a result of their dogmatic, zombie-like approach to the NUC's 'criteria', which echo loudly like voices in their heads. Is this a healthy development for the Nigerian academia? Surely not.

In my view, government bureaucrats should not be in the business of dictating course titles and their precise contents to any university. It is a regulatory overreach, and an insult to the more established institutions in Nigeria. Can anyone say that the likes of University of Lagos, University of Ibadan, Obafemi Awolowo University, Ahmadu Bello University, Bayero University, University of Port Harcourt, University of Nigeria, Nsukka etc, or, Afe Babalola University, Covenant University, Elizade University, Baze University, Backcock University etc, need some busybody to tell them what to teach and how to teach? There are many more similarly good universities, too numerous to mention. They should not be herded in the same direction. They should be allowed to play to their individual ambitions and strengths. Above all, they should be given maximum leeway to manage their curricula as they deem fit. Most academic courses these days are linked to professional bodies for additional certification anyway. That said, there would still be room for regulatory oversight, but not in the current one-size-fits-all manner. Once granted its corporate licence, a university should be allowed to run its institution free from the NUC diktats for a period of 10 to 20 years. The NUC would reserve the right to revoke the licence anytime, in case of an egregious breach of its mandate. This draconian power would be subject to final arbitration of the courts. The commission would also have the right to conduct an impromptu inspection of any university upon the receipt of a petition from interested parties. This can be described as 'light touch' or 'arms-length' regulation, fit for the 21st

Finally, in case you think this piece is unduly harsh on the NUC, this is what the agency cheerfully advertises on its website: "The Commission has recorded a number of successes since its inception. These successes can be attributed to the quality of its leadership, dedication and commitment of the staff, the quality of its Board members, cooperation received from universities and support from the Federal Government". As of today, there is not a single mention of any of the "successes" referred to. I rest my case.

Troops of I Division, FCC, Nigerian Army has released the names of the five rescued students of the Federal College of Forestry Mechanisation, Afaka, Kaduna who were kidnapped by bandits on March 11.

The Director, Army Public Relations, Brig.-Gen. Mohammed Yerima, who disclosed this in a statement recently in Abuja, gave the names of the students as Abubakar Yakubu, Francis Paul, Obadiya Habakkuk, Amina Yusuf and Maryam Danladi.

He said the rescued students are currently receiving medical attention in a military facility in Kaduna.

According to him, the General Officer Commanding (GOC) I Division, Nigerian Army, Maj.-Gen Danjuma Alli-Keffi, has commended the troops for their effort.

"He charged them not to rest on their oars until all kidnapped victims are rescued and returned to their families," he said.

Neptune Prime had reported that five students, out of the 39 that were abducted from the

Federal College of Forestry Mechanisation, Afaka, Kaduna were rescued after 25 days in custody.

Samuel Aruwan, the Commissioner for Internal Security and Home Affairs, had confirmed this in a statement on Monday.

Aruwan stated that they were recovered by the Nigerian Army troops on Monday afternoon and that they were undergoing an absolute medical check-up at the military facility.

## Major European Nations Suspend Use of AstraZeneca Vaccine

Germany, France and Italy became the latest countries to suspend use of the COVID-19 vaccine
 AstraZeneca says 37 reports of blood clots out of 17 million people vaccinated in Europe

ermany, France and Italy last week became the latest countries to suspend use of AstraZeneca's COVID-19 vaccine over reports of dangerous blood clots in some recipients, though the company and European regulators have said there is no evidence the shot is to blame.

Germany's health minister said the decision was taken on the advice of the country's vaccine regulator, the Paul Ehrlich Institute, which called for further investigation into seven reported cases of clots in the brains of people who had been vaccinated.

"Today's decision is a purely precautionary measure," Jens Spahn said.

French President Emmanuel Macron said his country would likewise suspend shots at least until Tuesday afternoon, when the European Union's drug regulatory agency will weigh in on the vaccine. He said France hopes to resume using the formula soon.

Italy's medicines regulator also announced a precautionary, temporary ban.

AstraZeneca said on its website that there have been 37 reports of blood clots out of more than 17 million people vaccinated in the 27-country European Union and Britain. The drugmaker said there is no evidence the vaccine carries an increased risk of clots.

In fact, it said the incidence of clots is much

lower than would be expected to occur naturally in a general population of this size and is similar to that of other licensed COVID-19 vaccines.

The European Medicines Agency and the World Health Organization have also said that the data does not suggest the vaccine caused the clots and that people should continue to be immunized.

The AstraZeneca shot has become a key tool in European countries' efforts to vaccinate their citizens against COVID-19. But Pfizer's and Moderna's vaccines are also used on the continent, and Johnson & Johnson's one-shot vaccine has been authorized but not yet delivered.

In the US, which relies on the Pfizer and Moderna vaccines, AstraZeneca is expected to apply any day now for authorization.

Blood clots can travel through the body and cause heart attacks, strokes and deadly blockages in the lungs. AstraZeneca reported 15 cases of deep vein thrombosis, or a type of clot that often develops in the legs, and 22 instances of pulmonary embolisms, or clots in the lungs.

Denmark last week became the first country to temporarily halt use of the AstraZeneca vaccine in recent days to investigate. It said one person developed clots and died 10 days after receiving at least one dose. The other countries include Ireland, Thailand, the Netherlands, Norway, Iceland, Congo and Bulgaria.

Last week, Germany and France were among the nations that stuck by the shot, while Italy suspended only a specific batch of the vaccine. Britain is standing by AstraZeneca's vaccine for now.

Spahn, the German health minister, said of the decision to suspend the AstraZeneca shot: "The most important thing for confidence is transparency." He said both first and second doses of the vaccine would be affected by the suspension.

German authorities have encouraged anyone who feels increasingly ill more than four days after receiving the shot — for example, with persistent headaches or dot-shaped bruises — to seek medical attention.

Germany has received slightly over 3 million doses of the AstraZeneca vaccine. Spahn said about 1.6 million doses of the shot have so far been administered in the country.

## National Hospital disowns kidney patient, Oghenekevwe

he National Hospital, Abuja has disown one Mrs. Roseline Oghenekevwe, a 40-year-old mother of three, who allegedly needs a kidney transplant, whose story was published in the Guardian Newspaper.

A report in the paper published on Tuesday September 5, 2017 quoted Oghenekevwe as suffering from an end stage renal disease, secondary to long-standing hypertension and retroviral diseases. Oghenekevwe said she

needed N11 million to enable her undergo kidney transplant at the National Hospital, Abuja.

A clinical administrator and senior medical officer at Kidney Solutions, Dr. Aderemi Oladapo-Sani, said the patient needed a definitive management of renal transplant from its partnering hospital, The National Hospital at the cost of N11 million.

But a letter from the National Hospital signed by Tayo Haastrup of the AD-HOD/

Information and Protocol management for the Chief Medical Director, said "the said patient is not known and has not been seen at the National Hospital. There is no record of her in our patients data base."

The letter added, "let it also be known that we are not partnering with any agency on kidney transplant and currently we do not carry out kidney transplant surgery in National Hospital Abuja."

## Privacy, Confidentiality & Medical Records (I)

o enable patients to participate meaningfully in decisions about health care, physicians have a responsibility to provide information and help patients understand their medical condition and options for treatment.

#### Informed consent & shared decision making

Informed consent to medical treatment is fundamental in both ethics and law. It helps patients make well-considered decisions about their care and treatment.

#### **Informed Consent**

Informed consent to medical treatment is fundamental in both ethics and law. Patients have the right to receive information and ask questions about recommended treatments so that they can make well-considered decisions about care. Successful communication in the patient-physician relationship fosters trust and supports shared decision making.

The process of informed consent occurs when communication between a patient and physician results in the patient's authorization or agreement to undergo a specific medical intervention. In seeking a patient's informed consent (or the consent of the patient's surrogate if the patient lacks decision-making capacity or declines to participate in making decisions), physicians should:

Assess the patient's ability to understand relevant medical information and the implications of treatment alternatives and to make an independent, voluntary decision.

Present relevant information accurately and sensitively, in keeping with the patient's preferences for receiving medical information. The physician should include information about:

The diagnosis (when known)

The nature and purpose of recommended interventions

The burdens, risks, and expected benefits of all options, including forgoing treatment

Document the informed consent conversation and the patient's (or surrogate's) decision in the medical record in some manner. When the patient/surrogate has provided specific written consent, the consent form should be included in the record.

In emergencies, when a decision must be made urgently, the patient is not able to participate in decision making, and the patient's surrogate is not available, physicians may initiate treatment without prior informed consent. In such situations, the physician should inform the patient/surrogate at the earliest opportunity and obtain consent for ongoing treatment in keeping with these guidelines.

#### Decisions for Adult Patients Who Lack Capacity

Respect for patient autonomy is central to professional ethics and physicians should involve patients in health care decisions commensurate with the patient's decisionmaking capacity. Even when a medical



condition or disorder impairs a patient's decision-making capacity, the patient may still be able to participate in some aspects of decision making. Physicians should engage patients whose capacity is impaired in decisions involving their own care to the greatest extent possible, including when the patient has previously designated a surrogate to make decisions on his or her behalf.

When a patient lacks decision-making capacity, the physician has an ethical responsibility to:

Identify an appropriate surrogate to make decisions on the patient's behalf:

The person the patient designated as surrogate through a durable power of attorney for health care or other mechanism

A family member or other intimate associate, in keeping with applicable law and policy if the patient has not previously designated a surrogate

Recognize that the patient's surrogate is entitled to the same respect as the patient.

Provide advice, guidance, and support to the

Assist the surrogate to make decisions in keeping with the standard of substituted judgment, basing decisions on:

The patient's preferences (if any) as expressed in an advance directive or as documented in the medical record.

The patient's views about life and how it should be lived.

How the patient constructed his or her life story.

The patient's attitudes toward sickness, suffering, and certain medical procedures.

Assist the surrogate to make decisions in keeping with the best interest standard when the patient's preferences and values are not known and cannot reasonably be inferred, such as when the patient has not previously

expressed preferences or has never had decision-making capacity. Best interest decisions should be based on:

The pain and suffering associated with the intervention

The degree of and potential for benefit Impairments that may result from the intervention

Quality of life as experienced by the patient Consult an ethics committee or other institutional resource when:

No surrogate is available or there is ongoing disagreement about who is the appropriate surrogate.

Ongoing disagreement about a treatment decision cannot be resolved.

The physician judges that the surrogate's decision:

Is clearly not what the patient would have decided when the patient's preferences are known or can be inferred

Could not reasonably be judged to be in the patient's best interest

Primarily serves the interests of the surrogate or other third party rather than the patient

#### Withholding Information from Patients

Truthful and open communication between physician and patient is essential for trust in the relationship and for respect for autonomy. Withholding pertinent medical information from patients in the belief that disclosure is medically contraindicated creates a conflict between the physician's obligations to promote patient welfare and to respect patient autonomy.

Except in emergency situations in which a patient is incapable of making an informed decision, withholding information without the patient's knowledge or consent is ethically unacceptable. When information has been withheld in such circumstances, physicians'

should convey that information once the emergency situation has been resolved, in keeping with relevant guidelines below.

The obligation to communicate truthfully about the patient's medical condition does not mean that the physician must communicate information to the patient immediately or all at once. Information may be conveyed over time in keeping with the patient's preferences and ability to comprehend the information. Physicians should always communicate sensitively and respectfully with patients.

With respect to disclosing or withholding information, physicians should:

Encourage the patient to specify preferences regarding communication of medical information, preferably before the information becomes available.

Honor a patient's request not to receive certain medical information or to convey the information to a designated surrogate, provided these requests appear to represent the patient's genuine wishes.

Assess the amount of information the patient is capable of receiving at a given time, and tailor disclosure to meet the patient's needs and expectations in keeping with the individual's preferences.

Consult with the patient's family, the physician's colleagues, or an ethics committee or other institutional resource for help in assessing the relative benefits and harms associated with delaying disclosure.

Monitor the patient carefully and offer full disclosure when the patient is able to decide whether to receive the information. This should be done according to a definite plan, so that disclosure is not permanently delayed. Disclose medical errors if they have occurred in the patient's care, in keeping with ethics guidance.



## Putin Signs Law Allowing Him To Hold Office For Two More Terms



ussian President Vladimir Putin has signed a law that would allow him to stay in office for two more terms until the year 2036.

legislation, officially approved by Putin, came after changes to the country's constitution last year that allowed

the 68-year-old Russian leader to run for two more six-year terms once his tenure ends in 2024.

The changes, which were overwhelmingly backed in a public vote last summer, permit Putin to potentially hold office until the age of 83.

The reforms also include an

amendment that grants former Russian presidents automatic immunity from criminal prosecution.

Putin is already the longestserving leader in modern Russian history since Soviet leader Josef Stalin and his supporters said at the time that the reforms were needed to ensure national stability.

The legislation was passed in both the lower and upper houses of Russian parliament last month.

Putin has ruled the country as a president or prime minister for more than 20 years.

## Saudi Arabia To Spend More In Next 10 Years Than In The Past 300 Years: Crown Prince

audi Arabia's Crown Prince Mohammed bin Salman said that the Kingdom will spend more in the next 10 years than it has done in the past 300 years as he announces a new program to strengthen partnership with the private sector.

During his announcement of the "Shareek" partner program between the private and public sectors, the Crown Prince announced that oil giant Aramco and petrochemical firm SABIC would lead investments of 5 trillion riyals (\$1.3 trillion) by the local private sector by 2030.

"When we're talking about 27 trillion Saudi riyals in the next 10 years, solid, we have it, solid. 3 trillion from the Public Investment Fund (PIF), we announced it and where we brought it from, committed to spend. Today, 5 trillion from the big companies, a



majority of which are governmentowned, solid and committed. 4 trillion riyals under a strategy to be announced later, part of it is business as usual and a bigger part of it is solid, we have it, 12 trillion riyals," the Crown Prince told a panel discussion of representatives from the private sector.

The total amount would rise to 27 trillion riyals with government domestic

Shareek (Partner) "The new program will help the private sector create hundreds of thousands of new jobs and will boost the contribution of the private sector to GDP by up to 65% by the end of the decade," the prince said.

He stressed that building a vibrant and prosperous private sector is one of the Kingdom's national priorities, given the importance it represents, and a vital role, as a major partner in the prosperity and development of the Kingdom's economy, to continue to perform its supportive tasks, to achieve the national aspirations set by Vision

"So there is spending in 10 years more than the history for the entire Kingdom of Saudi Arabia, since 300 years before the discovery oil and after. That's huge. That's huge. That is why we're talking with the big companies and the private sector, this is a huge opportunity. This is a new Kingdom of Saudi Arabia where spending is more than what has been spent the past 300 years," Crown Prince Mohammed bin Salman said.

## Provoking A Russian Siege Mentality Is Counterproductive For US Foreign Policy

eading Russian Senator Alexey Pushkov warned that the US is ✓ pursuing the aim of a "prolonged siege of 'Putin's Russia'" through "sanctions from hell", "push[ing] Ukraine into a new war in the Donbass", and "building up the armed forces on the borders with Russia and in the Black Sea", all of which would arguably be counterproductive for US foreign policy since Russia's resultant siege mentality might only accelerate the steps that the Eurasian Great Power could soon take to contain America in response.

Russian-American relations continue to dangerously deteriorate despite early February's last-minute salvaging of the New START nuclear pact. RT reported that leading Russian Senator Alexey Pushkov warned that the US is pursuing the aim of a "prolonged siege of 'Putin's Russia" through "sanctions from hell", "push[ing] Ukraine into a new war in the Donbass", and "building up the armed forces on the borders with Russia and in the Black Sea". All of this would arguably be counterproductive for US foreign policy since Russia's resultant siege mentality might only accelerate the steps that the Eurasian Great Power could soon take to contain America in response. I elaborated on this possible 20-point plan in my analysis last month which was written after Deputy Foreign Minister Sergei Ryabkov warned that his country was seriously countenancing such a scenario if American pressure on Russia doesn't soon end. I also predicted earlier this week that the US might be responsible for an informal Russian-Chinese-North Korean missile alliance that could created in the face of America's reported decision to deploy intermediate-range missiles to Japan in the coming future.

History testifies time and again that Russia has stood the test of multiple sieges from some of civilization's most powerful forces, which include the Mongols, the Polish-Lithuanian Commonwealth, the Swedish Empire, the Ottoman Empire, Napoleon, and Hitler among others. Although each



struggle was different in their own way, they all shared the common outcome of the Russian state eventually succeeding in the face of supreme adversity despite the dire consequences that some of the associated conflicts caused for its people. The ongoing New Cold War is no different in this respect. If anything, it's comparatively less intense than what Russia has confronted before, though the stakes are also a lot higher because of the feared nuclear factor that could be introduced through a war by miscalculation. The Russian people aren't being slaughtered like they were many times throughout history, nor are they starving. To the contrary, they're thriving

after the country finally emerged from the recent World War C-induced recession and even became the world's top wheat

As such, there's no doubt that Russia will survive this current US-imposed siege against it, but the ultimate question is what lasting geopolitical consequences its inevitable victory will have. Like was argued earlier, the longer that the siege lasts, the more counterproductive it'll be for the US' foreign policy. Russia will be pushed by circumstances into comprehensively strengthening its strategic ties with China, an outcome that many American voices have described as nightmarish but which may become a fait accompli unless more pragmatic minds prevail and the US lifts its current siege as soon as possible. The current state of affairs is such that the American-Chinese dimension of the New Cold War might drag on indefinitely so long as Russia isn't pressed to take ties with the People's Republic to an even higher level than they presently are, but the latter scenario that might be triggered by the US' intensified siege would decisively tilt the scales in Beijing's favor and eventually lead to Washington's loss. With this in mind, the US' grand strategic interests are best served by lifting its anti-Russian siege and thus offsetting that scenario.

#### Venezuelan Presid t Requests UN Aid To Clear Mines Along Border With Colombia

Fifteen people, including six Venezuelan soldiers and nine members of the armed groups, were also killed in clashes on Sunday, according to Caracas' official toll.

Dozens of armed militants were detained and their weapons, explosives and drugs seized. "We have dislodged (these groups) from several camps. They left a mined territory

behind... We have lost several soldiers with

these mines," Maduro said. The Socialist leader again accused the groups of ties "to the Colombian army and the government of Ivan Duque," the Colombian president. "They are dressed as guerrillas to serve the drug trafficking routes," he said.

Maduro assured the nation that all irregular groups from Colombia will be eradicated from Venezuela's western Apure region.

warned in a report that the residents in Apure and the neighboring eastern Colombian province of Arauca faced brutal violence from armed militants on a daily basis.

"Residents in Arauca and Apure live in fear, as armed groups recruit their children and impose their own rules, threaten residents, and punish those who disobey, even with murder or months of forced labor in the fields," HRW Americas director Jose Miguel Vivanco said at the time.

Security sources in Colombia say the armed groups are dissidents of the now-disbanded Revolutionary Armed Forces of Colombia (FARC) rebel group, which signed a peace agreement with Bogota in 2016 to end a half century of armed conflict.

But some guerrilla fighters have refused to

Colombia has also long accused Venezuela of shielding the armed groups on its soil, a charge Maduro denies.

Venezuela's defense ministry has in turn accused the Colombian government and the CIA of being supportive of the armed groups responsible for planting mines along the border between the two countries.

The neighboring South American nations cut diplomatic ties in 2019 after Bogota followed the United States' lead and recognized Venezuelan opposition figure Juan Guaido as the country's legitimate president.

The US has been pursuing regime change in Venezuela and has imposed crippling sanctions on the country to force Maduro out of power.



and to engage the audience. This early engagement is very important – if you don't spark interest in the first 2 minutes you are likely to lose the audience's attention for the rest of the speech.

In the body of the speech you should include your key points or messages – a good rule of thumb is no more than 3 to 4. Finally in the close, you bring the whole thing together. Restating the main messages and summarizing your key points. You may also have a call to action.

Always remember Mark Twain said about speech writing: Develop a strong opening and a strong close and keep them close together!

Let me give you another valuable tip: Anticipate questions develop and answers for them. So often a speaker is caught offguard because he or she had received an unexpected question. Of course, it is quite acceptable to say that you don't know the answer or deflect the question to someone else, but you don't want to do this through the entire Q/A session. Remember to keep your answers brief (30 seconds or less) and to incorporate the question in your answer.

When writing your speech you should refer to your favourite book of speeches (mine is The Penguin Book of Modern Speeches edited by Brian MacArthur ) and also make sure you have a book of quotations handy. Both of these will provide you with inspiration.

The ability to write and deliver inspiring speeches is a key skill in education and in business and one that, sadly, is rarely taught in schools.



(A law of Solon prohibited school being open before sunrise or after sunset to prevent the boys being exposed to the moral dangers of the deserted streets.) But whether there were fixed hours for gymnastics and for music, and what they were, we can only conjecture. Nor do we know whether the wrestling schools and the music schools were completely separate. The subjects were certainly taught in different rooms and by different teachers, and very probably the schools were quiet distinct. But it is not unlikely that they came to be situated in the same locality. This is suggested by the close connection of the gymnasia with intellectual culture at a later period. In any case, it must not be thought that all work and no play made Charicles a dull boy. As the palestras were generally surrounded by spacious grounds, it may be assumed that a considerable part of the time was occupied with play under proper supervision. Most of our common games were played in Athens, and the Greek educators had quite sound notions about their educational values.

No special provision was made at this period for the moral and intellectual education of the older boys. Sometimes about fourteen or fifteen, the sons of the wealthier citizens were transferred from the

palestra to the gymnasium, and subjected for two years to a more advanced courses of physical exercises under the expert care of a paidotribe. They were now permitted to be present at the law courts. How effective might be the informal education got from this participation in adult affairs will be evident when the character of the Athenian youth's environment is considered. As he went along the street he saw on every side product of the noblest art the world has known. Day by day he might hear the discussion of men of apt speech and wide experience on political questions, in the settlement of which they had a personal share; and in the settlement of take his appointed place in the theatre of Dionysus, and witness from morning to night the performance of the tragedies presented in competition for the prize given annually for tragic poetry. Surely there never was an age that made a richer or more varied appeal to the adolescent. Here, if ever, life itself was the real educator.

At the end of two or three years of this intermediate training, when he had reached the age of eighteen, the free-born Athenian youth was entered on the temple of Athens on his initiation reveals the spirit of the ephebiate. It ran as follows: "I will never disgrace my sacred arms, nor desert my comrade in the ranks. I will fight for temples and for public poverty, whether alone or with my fellows. I will obey the magistrates and observe the existing laws, and those the people may hereafter make. If anyone tries to overthrow or disobey the ordinances, I will resist him in their defense, whether alone or with my fellows.

#### GREEK EDUCATION

I will honour the temples and the religion of my forefathers. So help me, Aglauros, Enyalios, Ares, Zeus, Thallo, Auxo and Hegemone" The ordinary education now came completely to a stop, and for a year the ephebus had to labour hard in company with all youths of his own age leaning the use of arms and the various military movements, and practicing gymnastics under teachers and a censor appointed by the State. At the end of this year of training, he received a spear and a shield from the patrol force that guarded the frontiers and kept smugglers and brigands in check. But there were occasional periods of relaxation for the ephebi in the midst of their strenuous training. A special place was reserved for them in the theater, and they were frequently called on to take part in the religious processions on the feast-days of the gods. Their varied occupations in the latter function

are immortalized on the wonderful Parthenon frieze. The ephebic training, it may be added, went on without change till Athens fell under the power of Macedonia

#### The New Education

The new education was the inevitable result of the profound economic and political charges that came over the Athenian State during the first half of the fifth Century B.C. Before this time the Athenians had been mainly an agricultural community, but the great extension of trade following on the endeavor of Themistocles to make Athens the greatest maritime power in Greece called into being a new class of wealthy merchants, to dispute the claim of the landed aristocracy who had previously been the rulers. The final outcome of the conflicts between them was the establishment of a democracy in which every free-born citizen, whether rich or poor, had an equal share. Then came the life-anddeath struggle with Persia, from which Athens emerged with great glory and with added power. With doubted wisdom and justice, she seized the opportunity to convert the league of allied States, by means of which the victory had been won, into an empire on which she imposed her will.

## CHURCH HISTORY IN PLAIN LANGUAGE (VIII)

t Antioch, for the first time, Jesus' followers were called "Christians." Originally, opponents of the church used the term as a derogatory label for the "devotees of the Anointed One" (in Greek Christianoi). But the Nazarenes soon adopted it gladly.

Thus, Antioch grew in Christian influence. In time it succeeded Jerusalem as the center of missionary outreach. This was due in large part to the work of Saul of Tarsus, who joined Barnabas there about. A.D 44.

#### THE APOSTLE PAUL

No man – other than Jesus, of course – has shaped Christianity more than Saul (or, as Christian came to say, Paul, a name more familiar to the ear of Greekspeaking people). No one did more for the faith, but no one seemed less likely.

When Stephen had crumpled to the ground, bleeding from the stones thrown by his enraged accusers, Saul had stood nearby, as leader of the attack upon the Nazarenes. How, he asked, could anyone profess to follow a crucified Messiah? Almost by definition the Messiah is one upon whom the blessing of God rests in a unique way. What fool can believe that crucifixion is a

blessing from God?

Saul found the answer to that question when he confronted the Lord one day outside Damascus. He dropped blinded by a light and he heard a voice, "Saul, Saul, why are you persecuting me? Suddenly Stephen's argument fell into place, and Saul became a believer.

He later explained: The law pronounces a curse on everyone who fails to keep it in its entirety, so all who hope to gain God's favor by keeping the law are exposed to a curse. Fortunately, God provided a way of escape. "Christ redeemed us from the curse of the law, having become a curse for us." By hanging on a cross (Gal. 3:10-14, NIV).

Stephen, then, was right. The law of God was given for a time to convince men of their inability to fulfill the will of God and to leave them with no option except to embrace the good news of Jesus Christ's death and resurrection.

Christ's death and resurrection. That was strong medicine for Judaism. The authorities wanted no part of it. So persecutor of Christians became the persecuted among Christians. He was, however, a leader uniquely qualified to bridge the gap between Jewish and Gentile Christianity. He was a man of three worlds: Jewish, Greek, and

Roma

Though he had been educated in the strictest Jewish tradition and had studied under famous rabbi Gamaliel in Jerusalem, Paul spoke Greek fluently and was familiar with Greek thought and literature. This meant based on Old Testament beliefs and completely foreign to the Gentiles, in ways which gave him special freedom of movement, protection in his travels and access to the higher levels of society.

The title apostle or "send me" was never more appropriate. Paul made a series of trips throughout Asia Minor (today's Turkey) and Greece preaching Jesus as the Christ and planting churches of Gentile Believers.

Paul's converts were a mixed lot. A few of them were from honourable backgrounds, but the majority of them were pagans with sordid pasts. In one of his many letters, Paul remind his readers of their formal life: sexual immorality, idolaters, adulterers, male prostitutes, thieves, slanderers greedy, drunkards, and swindlers. But, say Paul, "You were washed, you were sanctified, you were justified in the name of Lord Jesus Christ and by the Spirit of our God" (1 Cor. 6:11, NIV).

What was the way to instill


Christian principles of morality in these churches? That question was at the heart of the continuing tensions between Jewish and Gentile believers in first century Christianity.

The Palestinian Christians, stepped in traditional Judaism, said, "Tell them that unless they submit to the Jewish law, in addition to believing in Jesus, there is no hope for their faith."

Paul, however, found this impossible. His own experience pointed another way. If a person could gain the righteousness of God by obeying the law, said Paul, I would have been the greatest in the kingdom. But righteousness by personal effort can only lead to failure. Man can be accepted as righteous only through God's undeserved mercy. This is grace. And grace always arises from the life, death, and resurrection of Jesus Christ.

Many Christians thought Paul was impossibly optimistic. They were deeply troubled by the decline in Christian morality they felt sure would come in the gentile churches. If you teach justification by faith alone, they argued, people will imagine that once they have accepted Christ by faith it does not really matter how they live.

Food protein contains amino acids are a compound of the atoms, mentioned earlier, combined in different ways. There are twentytwo different amino acids. Each food protien varies in the amount of amino acids it contains.

The body breaks down these amino acids and combines them in a dfiferent order to make body protein. Some chains of amino acids link up with other chains to form gian proteins. There are thousands of different kinds of protein in the body. All body

cells contain protein. As I said earlier, these cells are constantly beign repaied and replaced. This makes amino acids from food protein critical to good health. So, food protein's main role is to eventually become body protein. Some foods are called quality protein because they contain the right amino acids in the correct amounts for the body to turn into body protein. Other protein rich foods that do not fit this category can be combined to make quality protein.

Up to now protein sounds great. After all, the protein we eat is replacing the protein we are losing. All we have to remmeber is some foods need to be combined to get their full benefit. Then why not go on a high protein diet? This is evidently what took place during the 1970's when some deaths were linked to high protein diets. Scientists who studied the deaths found that the dieters had died of irregular heart rhythms and cardiac arrest.

When you take in more protein than you need for cell repari and replacement, you have an excess of amino acids. These amino acids are broken down by the liver to provide energy or to make fat, in a process called "deamination." When the liver has too much to process it ends up releasing large

amounts of the toxic compound "urea" into the blood. The urea is processed by the kidneys and excreted in the urine.

This can be very stressful on the liver and kidneys as they work overtime to rid the body of the toxic urea. Also in order to dilute the urea you will need to consume large amounts of water and your body may even make water from its own tissue. It is this water taken from the tissue that is the weight loss people experience when they go on a high protein diet. Two cups of water weights about one pound. It is only temporary weight loss because the tissue wants that water back. It only gave up the water to keep the toxic level under control.

There are times when you might want to consume a litre more than the Recommended Dietary Allowance (RDA) for protein. If you remember, that, protein is used for repair and replacement of cells, it is easy to understand, if you are sick or have an operation, your doctor may want you to receive a little high amount of protein. Also, if you are a bodybuilder you are interested in incrasing the size of your muscles, and that is adding cells. Recommended Dietary ALlowance (RDA) for protein is (approximately 10 to 15 percent

Why did I tell you this? SO you can be knowledgeable. So you can be suspicious of any diet low or high in protein.

Again we can be very thankful for our variety of foods, but you need to take advantage of this variety in any diet program. This variety is sometimes referred to as a balanced eating program. Be leery of any program that centers on a few foods, especially eating or drinking the same food twice a day. Over the years protein has remained nearly constant at 11 -12 percent of dietary energy in thsi country.

#### Chapter 9 The Wrong Thing To Eat and Why

The last body fuel is fat. It wil not benefit you to know what atoms make up the compound fat. But, just as with protein and carbohydrates, it will be of great help to know the characteristics of fat and the effect it has on your body. Fat contains nine calories per/gram and takes six to eight hours to burn.

As a nation we have increased our consumption of fat to what some experts say is an unhealthy level. It is recommended that less than 30 percent of our calories should

come from fat, yet, as a nation between 40 to 50 percent of our calories come from fat.

In 1993, based on scientific evidence, the US Department of Health and Human Services reported and/or recommended the following.

1. That there is a link between diets high in fat and some cancers 2. Th fat content of the American diet remains well above normal nutritional requirements.

3. A diet low in total fat may reduce the risk fo some cancers

4. Diets low in Saturated Fat and Cholesterol Decreae the risk of heart Diseae


5. An easy way to reduce the levels of Saturated Fat and Cholesterol in the diet is to reduce total fat consumed.

6. That less than 30 percent of your calories should cme from total fat.

The American Heart Association also recomends that less than 30 percent of your calorie intake should come from fat.

Wouldn't it be great if every item in the grocery store stated on the label the percent of calories that came from fat? Well, they don't! The Government wants to recommend what's healthy, but they dont want you to be too smart. A medical person knows the formula to figure out the percent of calories that come from fat, but what about the common person?

n the particular perspective through which we view this **L** problem of your angering yourself at me and viewing me as rotten when I do a rotten act (unfairly break our apartment-sharing agreement) you had better attempt to locate the primary or underlying irrationality to your feeling of anger at point C. Using what you have learned about the relationships existing between person and action, you see your underlying irrationality consists of making a false association between me and my action, that you have not effected the separation of the two. So although RET holds that there seem no absolute laws or rules that will apply to all people in every situation, you may still use its simple rule of thumb for discerning the difference between rB and iB in your Belief System:

Beliefs remain rational so long as they do not extend an evaluation of the action into an evaluation of the person. And further: you remain rational so long as you view the action in a limited way: by the effect that it has upon you who experience it. The evaluation of a person can only legitimately arise from evaluating all his or her acts over an entire lifetime. We cannot judge an individual's Belief System as totally irrational unless we find this person to have either a most severe psychotic disorder or severe mental retardation, yet surely every person alive holds an irrational Belief about something from time to time. People's Belief Systems as a whole

greatly determine their feelings and reactions; and remembering that that Belief System can maintain rBs and iBs simultaneously, we see that the Emotional Consequence—of an Activating Experience—whether inappropriate Consequence (iC) or appropriate Consequence (aC) depends upon the ratio of influence between iB and rB...

If, at point A, you feel inconvenienced or disappointed by a situation, then you may have a rational or appropriate feeling. But your emotion of anger at the person causing the inconvenience shows (at C) irrationality because you had better separate the evaluation of the action and the evaluation of the person even though most people do not make this separation and by confusing a damnable act with a damnable person, make themselves needlessly angry. One might expect you to feel disappointed, inconvenienced, or discouraged at C by these unfair actions, but to feel angry and hostile, to assume that the perpetrator of these actions is terrible proves irrational.

For the sake of clarity, we'd better look at the causal relationship between your iBs and your anger. Although we have no incontrovertible proof that these iBs constitute the most direct or even the only cause of anger, by looking at the intrinsic relationship between thought and feeling we find a very close connection between the two. We have seen that using the RET model, we have been able to point out to people their own iBs and, further, to teach them how to eliminate them. In

the process, we discovered that their anger diminished and disappeared.

While E would find it of great interest to investigate the transactional relationship between thinking and feeling, the huge amount of data that I would have to consider in order to render a clear and complete resolution to the discussion would go far beyond the scope of this book. Suffice it to say that although I only present RET as a theory, I know from clinical experience and from a mass of experimental data (summarized in the Rational-Emotive Therapy Handbook that I authored with Dr. Russell Grieger) that it works. While research continues and we await conclusive evidence concerning the exact nature of the relationship between thinking and feeling, we do best to content ourselves with the effective working theory that we now

Having established two aspects to your individual Belief Systemrational and irrational-you confront another problem. Earlier we showed that humans have a basically rational nature; for if they had not, they could. never have progressed to the point they have reached today. Why, then, should such rational animals have irrational beliefs (as our theory states) and act in accordance with them since they help destroy and contradict both their nature and their desire to get what they want? Many psychological theorists have debated this and similar questions, and unfortunately, few acceptable answers have come to light. We can

perhaps best approach the question by dividing human actions into two categories that seem present in every action: the primary aspect and the secondary (or component) aspect. Using our illustration, I will attempt to explain the two. of them.

When you made the decision to enter into the agreement with me, you perhaps felt that by making this arrangement, you would have what you considered a good living circumstance and would therefore feel happy. As your primary motive, you strove for happiness and contentment. This desire for happiness, as well as your arrangement with me seem rational—designed to help you get what you want. When I withdrew from the arrangement, you experienced frustration. You did not get what you wanted. Now, if we had never reached an agreement in the first place, you would have felt frustrated with the situation and perhaps disappointed, but you would not have felt angry with me. You would probably have simply judged my action as "bad" or undesirable. But now that J have withdrawn from our agreement, and although you remain in the same position as you would have been had we never entered into the agreement in the beginning, you feel incensed with me.

What makes you disappointed in one instance and angry in another even though your situation in regards to sharing an apartment with me stays the same in both e.g., we wont share one?

## Chapter One: The Long March to A West Wing Corner Office

**∠ ∠** I fully support the United States position that all options are on the table," which is as close as any Japanese politician can get to saying he could support offensive military operations. By contrast, Tillerson was announcing we wanted "to bring North Korea to the table for constructive, productive dialogue." He was obviously deep in the grip of "the building." When Trump announced new financial sanctions on North Korea, China responded by saying its central bank had directed all Chinese banks to cease doing business with Pyongyang, which was quite a step forward if actually carried out (and many were dubious).

Iran remained the most visible flashpoint, however, and in July Trump faced his second decision whether to certify Iran was complying with the nuclear deal. The first decision to do so had been a mistake, and now Trump was on the verge of repeating it. I wrote an op-ed for The Hill that appeared on its website on July 16, apparently setting off a daylong battle inside the White House. McMaster and Mnuchin held a conference call to brief reporters on the decision to certify Iranian compliance, and the White House e-mailed "talking points" to the media explaining the decision as their call was under way. But an outside analyst told me, "There's chaos at the NSC," the talking points were pulled back, and the decision to certify compliance was reversed. The New York Times, citing a White House official, reported on a nearly hourlong confrontation between Trump, on one side, and Mattis, Tillerson, and McMaster, on the other, on the certification issue, confirming what I had heard earlier. Other sources said the same thing. Trump ultimately succumbed, but not happily, and only after yet again asking for alternatives, of which his advisors said there were none. Bannon texted me, "POTUS loved it... Your op-ed drove him on Iran." Trump called me a few days later to complain about how the Iran certification issue had been handled, and especially about "people in the State Department" who hadn't given him any options. Then he said, referring to my last conversation with Tillerson, "I hear what Rex talked to you about won't work. Don't take some half-assed position over there. If he offers you something that's really great, okay, whatever, but otherwise just wait. I'm going to call you," concluding the call by saying I should "come and see [him] next week" on Iran. Bannon texted me right afterward,



"We talk about it/u everyday." I told Bannon I would write a plan about how the US could withdraw from the Iran deal. It would not be hard

The next day, Sean Spicer resigned as White House spokesman to protest Anthony Scaramucci's being named Communications Director, with Sarah Sanders picked as Spicer's successor. One week later, Trump fired Priebus, naming John Kelly, then Homeland Security Secretary and a former four-star Marine general, as White House Chief of Staff. On Monday, July 31, Kelly fired Scaramucci. mid-August, controversy erupted over Trump's comments about neo-Nazi demonstrators in Charlottesville, Virginia. He fired Bannon on August 18. Was this what business schools taught about running large organizations?

What was not happening was any White House sign of life on my Iran-deal exit strategy, which I had earlier transmitted to Bannon. When I sought a meeting with Trump, Westerhout suggested I first see Tillerson, which would have been a waste of time for both of us. I suspected that Kelly's efforts to bring discipline to White House operations and limit Oval Office anarchy in particular had resulted in my "walk-in" privileges' being suspended, along with those of many others. I thought it would be a shame to let my Iran plan wither, so I suggested to National Review editor Rich Lowry that he publish it, which he did at the end of August. Iran's Foreign Minister, Javad Zarif, immediately denounced my plan as "a huge failure for Washington." I knew I was on the right track. Most

of the Washington media, instead of focusing on the plan's substance, wrote instead on my loss of access to Trump, probably because they understood palace intrigue better than policy. Kushner texted me to say, "You are always welcome at the White House," and "Steve [Bannon] and I disagreed on many things, but we were in sync on Iran." In fact, Kushner invited me to meet on August 31 to go over his emerging Middle East peace plan, along with Iran. After a relatively long hiatus, I didn't think this meeting was accidental.

Nonetheless, still no word from Trump, although another Iran compliance certification, required every ninety days by statute, came due in October. The White House announced Trump would make a major Iran address on October 12, so I decided to stop being shy, phoning Westerhout to ask for a meeting. By then, Tillerson had reportedly called Trump "a fucking moron," which he refused to deny flatly. Rumors flew that Kelly wanted to resign as Chief of Staff and that Pompeo would replace him, although it was also regularly rumored that Pompeo would replace McMaster. I was still focused on Iran and wrote another op-ed for The Hill, hoping the magic might work again. It appeared on October 9, the same day I had lunch with Kushner in his West Wing office. Although we talked about his Middle East plan and Iran, what really got his attention was the photo I brought of the gaudy entrance to Special Counsel Robert Mueller's office, located in the building where my SuperPAC was located.

The media reported Trump's advisors were urging he decline to certify Iran as complying with the nuclear agreement but that the US nonetheless stay in the deal. I saw this as self-humiliation, but so desperate were the deal's advocates that they were willing to concede a critical point on compliance just to save the deal. Trump called me in the late afternoon of October 12 (the speech having been moved to Friday the thirteenth) to talk. "You and I are together on that deal, you may be a little tougher than I am, but we see it the same," he said. I answered that I could see from the press coverage he was likely to decertify Iran but still remain in the deal, which I said was at least a step forward. I asked to discuss the issue further when there was more time. "A hundred percent," said Trump. "Hundred percent. I know that's your view. I watch what you say very carefully." I asked if he would put a line in his speech that the agreement was under 24/7 review and that it was subject to being terminated at any time (thus eliminating the need to wait ninety days before having another shot at withdrawal and plainly making the fight over withdrawal

rather than "compliance," as the deal's supporters preferred). We talked about the language Trump might actually use as he dictated to others in the room.

Trump then raised the topic of Iran's Islamic Revolutionary Guard Corps, asking if he should designate it as a Foreign Terrorist Organization, thereby subjecting it to additional penalties and constraints. I urged him to do so because of the organization's control of Iran's nuclear and ballistic-missile programs, and its extensive support for radical Islamic terrorism, Sunni and Shia. Trump said he was hearing Iran would be particularly upset by this specific designation, and there might be blowback against US forces in Iraq and Syria, which I learned later was Mattis's position. But his argument was misdirected; if Mattis was correct, the answer was to provide more protection for our troops or withdraw them to focus on the main threat, Iran. As it turned out, it would take nearly two years to get the Revolutionary Guard designated as a Foreign Terrorist Organization, showing the immense staying power of a dug-in bureaucracy.

# **SULTANS OF SOKOTO (4)**

#### CHAPTER ONE: SHEHU USMAN DANFODIO 1804 - 1817, THE FOUNDER OF THE SOKOTO CALIPHATE

any books have been written about the Sokoto Jihad and Sokoto Caliphate. This book is different. It is different because it is the first book that has attempted to look at the entire history of the Sokoto Caliphate up to the present day by looking at the history, life, activities and contributions of the Caliphs and the Sultans right from Usman Danfodio to his Eminence Sultan Muhammad Sa'ad ABubakar III. This book brings out details about the personalities that shaped the history of Northern Nigeria since 1804. It is an interesting reading material for anyone who wants to understand the past and contemporary political history of Northern Nigeria. the book has been written by distinguished historians from a number of Universities in Northern Nigeria.

At the age of 20 he became an authority in his own right and was sought after by students. Abdullahi says he was taught the Qur'an by his father until the age of thirteen, after which he was left in the hands of his elder brother, Shehu. Under Shehu, Abdullahi read "al-Ishriniyat, al Witriyat, and the Six Poets. He also learnt from Shehu the science of the Unity from the Sanusi books and their commentaries, as well as other works. Again he learnt syntax, acquired knowledge of mysticism, learnt Qur'anic exegis, the science of the tradition which comes with knowledge, and the science of mathematics.' He also learnt Islamic law (Shari'ah) under Shehu.? Meanwhile as Shehu taught, he also preached, and as he preached and taught he continued to learn.

Very little was known about the Shehu in his formative years. But, according to Hiskett, oral traditions have it that "he was a man of medium height, with a light complexion... a black man, without a beard, except a very small one. He is also said to have been of slender build." And when he reached early adulthood, his piety, exceptional intellectual ability, and charming traits began to manifest, thereby attracting many supporters. Steadily, Shehu emerged as the leader of young Muslim scholars (Shaykh) with optimistic and reforming ideas. His relationship with his companions and with members of his household were warm and friendly and he clearly inspired them with confidence and warmth.

From his early manhood he lived a very simple life in that he had only one pair of



trousers, one turban, and one gown. He ate abstemiously and was disinterested in wealth and possessions, which he regarded as corruption. He earned his living by twisting rope, an occupation he could carry on while reading or teaching. His friends were men of his own kind: kinsmen, scholars, and visionaries who shared his interests and values. Consequently, 'they formed with him a close-knit community of intellectuals somewhat arrogant, in the way of those who know the moral certainties; deeply contemptuous of the pagan scene around them, and working enthusiastically together to advance the literacy culture upon which their religious ideology depended.

Teaching and Preaching

Islam reached Hausaland in about fourteenth century through the Mandingo merchants from Mali. In the areas that were later to be known as Northern Nigeria, the development of Islam was also identical with the Niger region. Here the first people to embrace Islam were the Borno people in about the 11th century while in Hausaland, 14th century is considered as the period of Islamic intrusion.

Although by the 14th century Islam was already in Hausaland yet it was far from fully accepted by the majority of the populace. What seems to have happened, according to Hiskett, was that individual Muslims from peripheral areas of North Africa and Egyptian traders after the initial patronage of the governments of the Habe States came into the Habe Kingdoms and settled, thereby - forming

small communities that gradually began to affect the pagan peoples.!" Little wonder, therefore, that in its first stage of diffusion, Islam was only nominally accepted by some Kings and courtiers mainly through usage of Islamic names and titles. But it was very much mixed up with traditional religions.

Thus, by the 17 century, Islam had not only invaded the courts but had made important inroads into the ranks of the general masses. By this time in Hausaland, it was not even foreigners but indigenous people themselves who had not only learned but were themselves teachers of Islamic sciences that were engaged in preaching. In Zamfara, area, however, it was only at about the beginning of the second half of the same century that the first Muslim rulers converted to Islam.!9 By this period also various villages grew around famous servants which became great outposts of Islamic teaching with zealots from far and wide. During the second half of the 18'\* century, for example, the region of Degel, where Shehu's family moved earlier, seemed to have been a center of attraction, especially to various Islamic scholarly groups who became identified with such other settlements in the area as Chimmola, Baraya Zaki, Marnona and Marannu. In this way one can safely say that the 17 and 18 centuries saw the dominance of Islam in both Borno and Hausaland. However, though rulers were by this period bearing Islamic name yet the belief in the Iskoki was too deeply rooted in their social and political consciousness to have been

displaced by Islam.

Thus, in most Hausa states Islam had by now moved away from a simple acceptance of the faith to the awareness of its fundamental bases. Irrational beliefs were giving way to intellectual awareness. As opposed to decline, Islam was, thus, by the 18 century increasing its influence all over Hausaland. There existed in various cities and villages a largely Islamized population in terms of the norms, values and identity, where rulers were also Islamized.

Shehu started his teaching and preaching at the age of 20 in the year 1188 A.H (1774/75). His focus was on the following: to strengthen Islam, cleanse it from the pagan practices, Which embellished and convert the pagans. From his base in Degel, Shehu began to travel round the countryside to spread the true faith. Which embellished and convert the pagans. He made converts wherever he went in the course of his preaching: teaching the rituals and the basic tenets of Islam. Many places he tried to correct the views and beliefs of those who were already enlightened. Abdullahi records that people from the country side came to him and remained with him as followers. But Shehu didn't stay only around his immediate environment, neither, did he preach alone. He travelled with his younger brother to Kebbi and Zamfara, Zaberma and to Niger, as well as Daura's where he achieved great success. But in Zamfara he had to spend five years because he found the people almost completely ignorant of Islam.
